




Thursday, January 13 Report on COP26

Thursday, January 27 The Shadow of Gold

The Shadow of Gold pulls back the curtain on the world's most coveted heavy metal. Filmed in Canada (Mount Polley, B.C.), the U.S., London, Dubai, China, Peru and the Democratic Republic of Congo, the feature film is an incisive global investigation of the gold trade, from raw material to market, exposing its impact on human lives, the economy and the planet.



The film explores the mining industry from large-scale corporations that dig deep into mountains to extract gold from low-grade ore using toxic methods that haven't changed in more than 120 years to artisanal miners—an estimated 20 million people in the world's poorest nations—who extract gold by hand, producing just enough to survive

The documentary examines how industrial-scale mines are allowed to destroy ecosystems with impunity around the globe, how the illegal gold trade drives conflict and sustains organized terrorist groups. It also uncovers how gold linked to ecological disaster, the black market, and war enters the supply chain to reach unaware consumers. .



their communities. EPI's recent report (1 of 4 maps from their recent e-mail is shown here) shows that states with higher unionization levels tend to have more equitable democracies and economic and social structures:

- Minimum wages in the 17 U.S. states with the highest union densities are on average 19% higher than the national average and 40% higher than those in low-density states.
- States with the highest union densities have an uninsured population 4.5% points lower, on average, than that of low-union-density states (health insurance).
- ◆ Unions don't just help those workers who are in them. The relationship between high union density and higher household incomes overall, greater access to health care and paid leave, and fewer voting restrictions highlights the importance of protecting the right of workers to organize, including by passing the Protecting the Right to Organize (PRO) Act.

Call for Applicants UUJEC Economic Justice Leadership Award

UUJEC, in its commitment to celebrate and support economic justice, is seeking active Congregations or Justice Committees to apply for its biannual *Economic Justice Leadership Award*. The award will be presented to one UU congregation actively working for economic justice through systemic change (policy work, political activism, addressing inequality, climate justice, etc.). We'd like to hear about your work, however big or small, complex or focused.

The application contains multiple questions each to be answered in about 400 words or less (2,000 characters). The deadline to apply is May 1st at midnight. The award recipient will be selected and notified by June 1st with the award presentation scheduled remotely or in person for Summer 2022. The recipient will also have an opportunity to share their best practices as a Featured Group in a UUJEC webinar in the fall of 2022.

In addition to the award recipient, all congregations applying will be recognized with a commitment from UUJEC to help promote their work widely. NEWS ABOUT HEALTH

The pandemic continues.

At the end of December, more than 800,000 Americans were reported dead because of the disease. The UUJEC responded to the crisis at the 2021 General Assembly by developing an Action of Immediate Witness in support of Medicare for All. In 2022, the UUJEC's work for medical care reform continue.

Is called for in the 2021 Action of Immediate Witness, and something the UUJEC has been doing for some time. One of the organizations that has been leading the way since at least the negotiations that led to PP-ACA (a.k.a. Obamacare) in 2010 is Healthcare-NOW!, and we encourage people to check out their conference in April.

UU Compass Conference

The Compass conference held on-line on December 11 & 12 gave approximately 200 UUs nationwide the chance to reflect on their values and beliefs. The event opened with statements from four non-UUs: from a public health expert, from two members of the Rising Appalachia musical group, and from a self-described "queer black trouble-maker". They spoke about what religion and faith means to them and their interactions with UU activities and individuals.

A panel of UUs—young adults, a religious educator and clergy members—responded to what they'd just heard. Perhaps the heart of the conference was the chance for UUs from across the country to share personal beliefs and reactions to the speakers. The chats interspersed throughout the conference gave small groups of attendees the chance to share ideas and experiences.

At the end, time was set aside to hear about and reflect on the Article II project. A proposal will be made to the UUA Board by Jan. 2023, not only on the viability of an Eighth Principle supporting racial equity, but also on revisions to Article II in its entirety: UU purposes, principles and sources. Attendees had their voices heard in this process.

The event demonstrated how on-line gatherings can foster dialogue among UUs across the country, in a way that makes it much easier for those of all income levels and of all ages to participate.

- 8 ARTICLE II Principles and Purposes
- 9 Section C-2.1. Principles.
- 10 We, the member congregations of the Unitarian Universalist
